## Summary.

Please read the following terms and conditions carefully before purchasing or using event tickets for Kentico Partner Connection 2024. These terms and conditions govern your rights and obligations related to the purchase, possession, and use of the event tickets. By purchasing or using Kentico Connection 2024 tickets, you acknowledge and agree to be bound by these terms and conditions.

## Ticket purchase and delivery.

- All ticket sales are final. No refunds or exchanges will be provided, except as required by law.
- Tickets may only be purchased from [kentico.com](https://kentico.com) website. Unauthorized resale or distribution of tickets is strictly prohibited and may result in the cancellation of the ticket without refund.
- The ticket holder must provide accurate and complete personal information at the time of purchase.

## Ticket use and entry.

- Each ticket is valid for a purchaser to the specified event.
- The ticket holder must bring a valid identification document matching the name provided in the registration form for entry to the event.
- The event organizer reserves the right to refuse entry or remove any ticket holder from the event premises for reasons including, but not limited to, disorderly conduct, intoxication, violation of event rules, or failure to comply with security or venue requirements.
- The event organizer may make changes to the event program, date, time, venue, or performers, and such changes will not entitle ticket holders to a refund or compensation, unless required by law.

## Ticket conditions and restrictions.

- The ticket holder assumes all risks and dangers incidental to the event, whether occurring prior to, during, or after the event, including but not limited to personal injury, property damage, or loss.
- The ticket holder must comply with all applicable laws, regulations, and event rules. Failure to do so may result in removal from the event premises without refund.
- The resale or attempted resale of tickets at a price higher than the face value is strictly prohibited and may result in the cancellation of the ticket without refund.

## Video/Photography consent

- By attending Kentico Partner Connection 2024, you consent to being photographed and recorded by video during the event. You acknowledge that Kentico and its partners have the right to use such photographs and videos, which may include your image or likeness, for promotional, marketing, or other business purposes. These images and recordings may be used in various media formats, worldwide, at any time without further notification or compensation to you.

## Liability and indemnification.

- These terms and conditions shall be governed by and construed in accordance with the laws of the jurisdiction where the event takes place.
- Any dispute arising out of or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts in the jurisdiction where the event takes place.
